





















Unidad funcional 1 Kwh generado y distribuido











## El parque eólico Kilgallioch

## Alcance del proyecto – Recopilación inventario



#### RAW MATERIALS AND WTG MANUFACTURING

- •Raw materials needed for the wind turbines and their components
- Manufacturing processes required to build the wind turbine components
- Assembly of components in Gamesa facilities

#### LOGISTICS

- Transport of materials and components between Gamesa and its suppliers
- •Transport of the main components from Gamesa facilities until the Kilgallioch windfarm
- •Transport of the substation assets from the providers until Kilgallioch
- •Transport of other construction materials

#### WIND FARM CONSTRUCTION AND COMMISIONING

- •Raw materials used during the construction including foundations and internal wind farm wiring
- Machinery use for construction purposes and for WTG assemblies
- •Residues generated during the wind farm construction and its management

#### KILGALLIOCH OPERATION & MAINTENANCE

- •Energy generation at Kilgallioch wind farm during 25 years
- ·Wind farm internal electricity losses
- Planned preventive maintenance
- Expected corrective maintenance
- Operation residues management

#### END OF LIFE OF THE ASSETS



- Management of the different residues generated after decommissioning of the wind farm
- End of life treatments

#### LOSSES IN THE ELECTRICAL NETWORK

• Electrical losses from Kilgallioch electrical substation until Mark Hill electrical substation

#### ELECTRICAL NETWORK INFRASTRUCTURE

- Construction of the 14 Km underground line from Kilgallioch to Mark Hill
- Mark Hill substation expansion






